The COACT, Inc. CAFE Lab is an evaluation and test facility accredited by the National Volunteer Laboratory Accreditation Program (NVLAP) under lab code 200416-0. The COACT, Inc. CAFE Lab is accredited for Information Technology Security Testing; Common Criteria Testing.

Common Criteria Testing Laboratory

Since 1999, the COACT CAFE Lab has been an independent Common Criteria Test Laboratory (CCTL). The CAFE Lab CCTL is overseen by the National Information Assurance Partnership (NIAP) Common Criteria Evaluation and Validation Scheme (CCEVS) Validation Body.

CCEVS validates the results of security evaluations conducted by CCTLs and issues the Common Criteria certificate. The certificate, together with its associated validation report, confirms that an IT product or protection profile has been evaluated at an accredited laboratory using the Common Evaluation Methodology for conformance to the Common Criteria. The certificate also confirms that the IT security evaluation has been conducted in accordance with the provisions of the scheme and that the conclusions of the testing laboratory are consistent with the evidence presented during the evaluation.

The CAFE Lab has evaluated numerous and diverse product types including switches, multi-function printers, networked data storage devices, databases, firewalls, VPNs, secure wireless devices, and intrusion detection/protection systems. COACT, Inc. experience ranges from Evaluation Assurance Level 1 (EAL1) through Evaluation Assurance Level 7 (EAL7) evaluations and Protection Profile conformant evaluations. In fact, the COACT, Inc. CCTL is credited with being the first and only U.S. CCTL to perform (2) EAL7 evaluations.
